Eligibility for Supervisor (Guide) for Ph.D. Programme under Srimanta Sankaradeva University of Health Sciences.

- Aspiring Supervisors shall apply to the Registrar (Academic) in the prescribed format (Annexure- II).
- Every candidate shall carry out the research work under the guidance of a Research Supervisor. If necessary, particularly in case of multidisciplinary research, besides the Supervisor, there may be upto a maximum of two Co-Supervisor(s).

For allocation as Supervisor/Co-supervisor/Joint-supervisor under SSUHS, the following criteria shall be followed:

i) <u>Supervisor:</u>

- a) Any regular Professor having 4 (four) research paper publications as first author/corresponding author in peer reviewed indexed scientific journals but with 2 (two) in the last 5 (five) years shall be eligible.
- b) Any regular Associate Professor with Ph.D. degree and 4 (four) research paper publications in peer reviewed indexed scientific journals as first author but with 2 (two) in the last five years shall be eligible.
- c) Assistant Professors shall not be considered as Ph.D. Supervisors under SSUHS.
- ii) <u>Co-Supervisor</u>: When proposed doctoral work is of interdisciplinary nature, a Co-Supervisor may be allotted from other departments of the same institute or from other related institutions with approval of the Department Research Committee (DRC). Criteria shall be the same as Supervisor.
- Joint Supervisor: A Joint Supervisor may be from any other institute, provided he/she is an outstanding contributor in that specific field and his/her involvement will bring value to the research project when the DRC opines that the expertise in the department has to be supplemented from outside. Criteria shall be the same as Supervisor.
